1. Chhatradev Rural Municipality, Office of Rural Municipal Executive invites electronic bids from Nepalese eligible bidders for the following works under National Competitive Bidding procedures.

Bidders, submitting their bid electronically, should deposit **NRs. 3000** (for each) as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at Chhatradev rural Municipality, Office of Rural Municipal Executive at **13:00 Hours** on **2077/07/12**.
5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before **12:00 Hours** on **2077/07/20**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 Hours** on **2077/07/20** at the office of Chhatradev rural Municipality, Office of Rural Municipal Executive. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security (Amounting as mentioned below) or scanned copy of the bid security in .pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid **2077/11/21**.
7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
