- 3. The suppliers should provide copies of Company registration certificate, tax clearance certificate for the FY2075/076, VAT/PAN registration and self declaration related to Rule 40 subrule 2 (e) of Public Procurement Rule, 2074 to be elligible.
- 4. Sealed Quotation Forms may be purchased by eligible Suppliers on or before 2075/10/20 on the submission of a written application and upon payment of a non refundable fee of Rs 1,000.00
- 5. Sealed Quotations must be submitted to the above office on or before 12.00 hours on 2075/10/21. Quotation received after this deadline shall not be accepted.
- 6. Quotations must be valid for a period of 45 days after opening of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned below which shall be valid for 75 days after opening of the Sealed Quotations.

If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No 9590100221 in the name of The Chhatradev Rural Municipality, Office of the Rural Municipal Executive, Chhatragunj, Arghakhanchi at Nepal Bangladesh Bank, Chhatraganja Branch Arghakhanchi and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
